Examination of human capital theories of human resource management including issues of organizational structure and its impact on human/organizational performance.

Late Policy:

19. ADDITIONAL INFORMATION

Discussion board: The discussion board is where you "attend" class and share ideas based on theoretical research with your colleagues. <u>Literature Reviews</u>: Complete two (2) literature reviews using research-based, peer-reviewed sources. See Blackboard for topics and rubric. Steps:

- 1. Identify a topic
- 2. Find your key article
- 3. Find two sources that support the key article
- 4. Examine one or two additional sources that contradict your key article
- 5. Analyze and synthesize the articles and write your review

<u>Audio-Enabled Presentation</u>: Create an audio-enabled PowerPoint presentation for one of the theoretical approaches to Human Resources Development covered in this course. Presentations are part of the Week 7 discussion board and must be posted by Sunday, Midnight at the end of Week 6. See blackboard for more information, template, and rubric.
