# **Course Information**

**Catalog Description:** Examines the basic principles of neuroscience and pharmacology and applies this information to understand the proper use of the major classes of psychiatric medications and the role of the counselor in facilitating proper treatment.

**Course Outcome Competencies:** Upon completion of this course, students will be able to:

- Demonstrate knowledge in the following areas:
  - 1. basic elements of the anatomy and physiology of the brain
  - 2. basics elements of pharmacology
  - 3. major classes of psycho-active medications and situations in which they are used
  - 4. side-effects and interactions of medications
- Apply information about medications to situations associated with counseling
- Think critically about the relationship of mind and body in the treatment of mental illness

# **Attendance Requirements**

#### WBUonline (Virtual Campus)

Students are expected to participate in all required instructional activities in their courses. Online courses are no different in this regard; however, participation must be defined in a different manner. Student "attendance" in an online course is defined as active participation in the course as described in the course syllabus. Instructors may also file a Report of Unsatisfactory Progress for students with excessive non-participation. Any student who has not actively participated in an online class prior to the census date for any given session is considered a "no-show" and will be administratively withdrawn from the class without record. To be counted as actively participating, it is not sufficient to log in and view the course. The student must be submitting work as described in the course syllabus. Additional attendance and participation policies for each course, as defined by the instructor in the course syllabus, are considered a part of the university's attendance policy.
