 - Treatment of privacy sub topic (10 %)
 - Treatment of confidentiality sub topic (10%)
 - Treatment of security sub topic (10%)
 - Treatment of ethical and other issues (10%)
 - Flow – tying all subtopics together (30%)
 - Cite from at least three (3) references **(10%)**
 - Formatting **(20%)**
 - Use APA formatting
 - Minimum 5 pages and max 7 pages (not counting cover and reference page).
 - Must use subheadings – two of which must be INTRODUCTION and CONCLUSION (Must also use other subheadings)
 - Spelling and grammar errors will be penalized

Each Student must make one post (80%) and reply to at least two other students (10% + 10%)

The initial post should:

 - c. and the issues involved
