# **Course Requirements and Grading Criteria**

All assignments may be found in folders set up for each week of the course. The weekly schedule is outlined in the 'Schedule' section below. All assignments for the week must be completed by 11:59 pm (Central time zone) on Sunday night. Some assignments may be available early if you want to work ahead. Discussions will need to be completed during the week assigned. Students who have circumstances which prevent them from participating or completing an assignment on time must communicate with me in order to find reasonable accommodations to complete the required course work.

<u>Weekly Reading Quizzes:</u> You will have quizzes each week, one covering each chapter in the text (see schedule below). The quizzes are open book and untimed and they may be retaken once. These quizzes will be very important to prepare you for the exams. The quiz grades will total 250 points (20%) of your final grade.

<u>Midterm and final exams:</u> You will take a midterm (chapters 1-9) and a final exam (chapters 10-17). These will be timed and you will only have one chance to take them. The quizzes will be very helpful in preparing for the exams. Questions will be objective (multiple choice, etc.) like the quizzes. The two exams will total 500 points (40%) of the final grade.

<u>Weekly discussion board and/or other assignment:</u> Each week will have a discussion board and/or another assignment to complete. Your work is not to be simply copied from another source (see academic dishonest policy). I take plagiarism seriously! Your work should be thoughtful and thorough, demonstrating your understanding of the material. Responses to other students on discussion board should be substantive and make a contribution to the course. They should also be respectful to all other people. Discussion topics will generally require an initial post by Thursday night. The average of these assignments will be 20% of the final grade.

<u>Project:</u> Use the "Arson Trial Case" document provided on in the project assignment on Blackboard to complete this assignment. Imagine that you are a forensic expert preparing to give testimony for this case. Write a report covering each of the following:

- 1. List and briefly describe THREE areas (for example, jury selection) to which a forensic psychologist could be asked to contribute to this case.
- 2. For EACH of the three areas above, list and briefly explain three concepts from the text that would apply to that area in this case.
- 3. Choose ONE of the areas above as the area that you have been contracted to testify. Use this area of the case for the next two items.
- 4. Describe 'your' credentials: Describe the credentials of a person who would be well-qualified to be an expert in this area in your case. Be sure to briefly explain/justify your expertise for this case.
- 5. Write a report further explaining some points that the psychologist might make in testimony about this case. You can use the three concepts above (in part 2), but may add others. Explain how these concepts would help the psychologist make recommendation in this case. What are some specific recommendation/statements that a psychologist could make? Be sure to cite sources to support your points. You may cite the textbook, but should also cite at least two outside sources.

<u>Total paper should be 6-8 pages</u>, including references. **Due Week 7.** Grade on this project is 250 points (20%) of final grade.

#### The University has a standard grade scale:
