Course Outcome Competencies: Upon the conclusion of this course students actively engaged in learning will be able to:

- 1. Create a working syllabus that demonstrates rigor and research (must be approved by Dr. Mendoza) that furthers the student's knowledge in the field of study and includes the following three competencies.
- 2. Demonstrate how the chosen topic is connected to the student's field of interest and explain why it should be included in the scholarly conversation.
- 3. Communicate persuasively about the subject selected in both a written and oral assignment.
- 4. Conduct in-depth research on the chosen topic that applies the content to the theories of leadership.
- 5. Produce doctoral-level deliverables outlined in the approved syllabus (created in number 1).

Course Requirements:

WEEK 1— (10%)

Reading: Articles listed above, and Drees Chapters 1, 4, & 7

Video: Watch Professor's Lecture

Assignment: Using the Template found in Blackboard, create your syllabus and turn it in on Sunday at the latest. (Once approved, you may start. The sooner you get your syllabus in, the sooner you can work on your own course.) Here is what must be included:

- 1. Each week must have a required reading. (Your reading will not go through the bookstore, so you will need a way to access the reading you put into your syllabus.)
- **2.** You must have an assignment EACH week that is doctoral level.
- **3.** You must include at least one oral and one written assignment to meet the course objectives above. (You will have your own course objectives in your syllabus, but you may include these as well.)
- **4.** You will need to include a final research paper (topic of your choosing, that will add up to 150 points)
- 5. You will need to include a grading matrix that explains how many points are attached to each assignment (see above). The total points for this class should add up to 1,000 points in total. (You will notice that the syllabus and final assignment have already been plugged in. That leaves you with 750 points)

WEEKS 2-7— (75%)

Will vary per student.

WEEK 8— (15%)

Final Research paper turned in by Saturday by midnight.

"Students shall have protection through orderly procedures against prejudices or capricious academic evaluation.
