### **Course Information**

**Catalog Description:** Sociocultural, historical, legal, and clinical issues related to gambling, sexual, eating, alcohol, or drug addictions; theories and therapeutic approaches for treatment and prevention.

- Identify and explain the models of addiction.
- Describe, evaluate and apply the various assessment and treatment approaches of addiction counseling

### **Attendance Requirements**

#### WBU Online

**Course Outcome Competencies:** Upon completion of this course the student should be able to apply principles of counseling and understand the etiology of substance abuse, gambling, sex, and porn addition. Students will be able to apply treatment theories to assist patients with these addictive disorders for abstinence and recovery.

- 1. Develop an understanding of the cause of addiction.
- 2. Explore various theories and applied research to the practice to addiction counseling.
- 3. Be able to assess and treat addiction.

**Attendance Requirements:** Although our class will never meet face to face, it is imperative that you log on to Black board and participate and complete the assignments weekly on-line. As with any master level seminar, you need to read the assigned text articles, watch the videos and be prepared to respond in a substantive manner. A part of the assignments is to practice writing scholarly and use proper APA format. That is just the foundation. Our goal is to transform Blackboard into a learning lab through interaction, engagement, and participation.

Effective online participation may include offering new and unique insights, clarifying issues and complexities, reframing and extending ideas in meaningful ways, and offering a perspective that helps integrate and synthesize readings, ideas, and topics. ### **Course Assignments:**

**Discussion Boards** – Each assignment is due Wednesday night by (11:59 pm) midnight CST. The assignment will be up to 1-4 questions that you need to answer using the assigned readings for the week. Each question will state that the answer should be a synthesis of the readings, not summaries. Summaries of the assigned text, videos or journal articles will result in a grade of zero. For each question follows the criteria defined for that specific question, which includes word count, assigned text to be used, or outside articles incorporated (if applicable). Any articles used must be within the last 5 years and peer reviewed if possible. Other journal articles older than five years can be submitted if they are relevant to the discussion or research. Your weekly grade for the entire set of questions for the week will be worth 50 points all together.

**Peer Response** – Each Monday you will have 2 peer responses due by 9am CST. You should respond to 2 classmates in a substantive manner, which should demonstrate scholarship and critical analysis. Use at least 1 outside source for each response to substantiate your assertions. The more you respond to classmates, and the more comprehensively you respond will increase your grade for this peer response. Your weekly grade for the peer response is worth 25 points.

**Midterm Exam** will be administered consisting of 50 multiple choice questions. The test will be submitted over the reading and written assignments in weeks 1-3. The exam is open book and will have a two-hour time limit.

There will be extra time this week. Please use this time to read and prepare your research paper.

**Final Exam** will be administered consisting of 50 multiple choice questions. The test will be submitted over the reading and written assignments in weeks 5-7. The exam is open book and will have a two hour limit.

**Research Paper** - A research paper will be completed on motivational interviewing theory and cognitive behavioral therapy theory for addictions counseling. The research paper should compare and contrast these two counseling theories. Some areas to review are the following. Can motivational interviewing be used as a stand alone counseling theory? Is it better to use with another theory of counseling with motivational interviewing? The paper should be a minimum of 8-10 pages of content, excluding coversheet and references. Ten (10) peer reviewed, scholarly journal articles should be properly cited and noted in the bibliography. Please use APA format. The paper will be submitted to Safe Assignment. If Safe Assignment detects more than 20% match of previously written work, we will have a discussion. The total point value for this research paper is 200 points. This paper should include an introduction, literature review, discussion, and conclusion section. Please use these headings. Subheadings can be used as needed.

#### The University has a standard grade scale:

A 90-100, B = 80-89, C = 70-79, D = 60-69, F= below 60, W = Withdrawal, WP = withdrew passing, WF = withdrew failing, I = incomplete. An incomplete may be given within the last two weeks of a long term, within the last week of an 8-week session, or within the last two days of a microterm to a student who is passing, but has not completed a term paper, examination, or other required work for reasons beyond the student's control. A grade of "incomplete" is changed if the work required is completed prior to the last day of the next long 16-week term or 8-week session, unless the instructor designates an earlier date for completion. If the work is not completed by the appropriate date, the I is converted to an F.
