- 2. Students will evaluate the literature of the doctrine of the atonement

- 3. Students will analyze the various views on the atonement.
- 4. Students will recognize classical expressions of views on the atonement.

Attendance Requirements: WBU Online

Students are expected to participate in all required instructional activities in their courses. Online courses are no different in this regard; however, participation must be defined in a different manner. Student "attendance" in an online course is defined as active participation in the course as described in the course syllabus. Instructors in online courses are responsible for providing students with clear instructions for how they are required to participate in the course. Additionally, instructors are responsible for incorporating specific instructional activities within their course and will, at a minimum, have weekly mechanisms for documenting student participation. These mechanisms may include, but are not limited to, participating in a weekly discussion board, submitting/completing assignments in Blackboard, or communicating with the instructor. Students aware of necessary absences must inform the professor with as much advance notice as possible in order to make appropriate arrangements. Any student absent 25 percent or more of the online course, i.e., non-participatory during 2 or more weeks of an 8-week session, may receive an F for that course. Instructors may also file a Predict Report for students with excessive non-participation. Any student who has not actively participated in an online class prior to the census date for any given session is considered a "no-show" and will be administratively withdrawn from the class without record. To be counted as actively participating, it is not sufficient to log in and view the course. The student must be submitting work as described in the course syllabus. Additional attendance and participation policies for each course, as defined by the instructor in the course syllabus, are considered a part of the university's attendance policy.

Course Requirements and Grading Criteria:

Annotated Bibliography: Students will complete an annotated bibliography of no less than 12 sources. The bibliography will consist of selections that are books or referred journal articles that specifically describe or delineate the doctrine of the atonement. 15% of final grade

Position papers: The student will write four position papers that describe and explain the four main views on the atonement that will be examined during the session. Papers should reflect understanding of not only the primary textbook for the session, but also additional research into each position. 60% of the final grade

Book Journal: Graduate students will write a weekly journal discussing the chapters in Gustav Aulen's *Christus Victor*. Journal entries will be posted in the journal apparatus in Blackboard each week. 15% of final grade

Discussion Board: Students will interact with discussion board questions posted each week. These are designed to further student understanding of the theological questions which arise from the readings. 10% of final grade
