- 2. Students are expected to participate in all required instructional activities in their courses.

- 7. When a student reaches a number of absences considered by the instructor to be excessive, the instructor will submit a Report of Unsatisfactory Progress to the student's WBU student email account and to appropriate university personnel.

Course Requirements and Grading Criteria:

- Reading Reports on Primary Sources: I will assign primary sources pertaining to Baptist history each week. The student will prepare five reading reports on these primary sources. The reading reports need to include a summary of the contents and an analysis of the individuals related to the primary source, such as the author or recipient of the document, the historical context of the document and the significance of the document for the understanding of church history. Each report should be 2 to 3 pages in length. Further information can be found on blackboard.
- **Discussion Board**: Class members will participate in weekly discussion board topics supplied by the instructor. Discussion can come from the text, notes and primary sources available for the weekly reading reports.
- **Book Review**: Class members will prepare a book review from a list of books provided by the instructor. The book review will be 5 to 6 pages in length and will include an analysis of the book's contents and a critique of the book. The approved list will be found on blackboard. **The book review will be due at the end of week eight.**
- **Research Paper:** Students will prepare a 20-22 page research paper over a topic in Baptist history approved by the instructor. The paper must adhere to the guidelines published by Wayland's School of Religion and

Philosophy, available at

http://www.wbu.edu/academics/schools/religion and philosophy/student help/documents/Digest.pdf. A list of approved topics will be included in blackboard. The research paper is due the end of week ten.
