### COURSE OUTCOMES AND COMPETENCIES:

1. Demonstrate knowledge of the nature and canon of the Old Testament.
2. Demonstrate knowledge of the content and significance of the books of Genesis through Malachi.
3. Demonstrate knowledge of the cultural, social, and historical background from Abraham through the Restoration.
4. Demonstrate knowledge of the characteristics of Hebrew Poetry, Wisdom Literature, and Prophetic literature.
5. Demonstrate competency in conducting graduate level research, writing, and teaching/oral presentations.

### ATTENDANCE REQUIREMENTS:

Students are expected to participate in all required instructional activities in their courses. Online courses are no different in this regard; however, participation must be defined in a different manner. Student "attendance" in an online course is defined as active participation in the course as described in the course syllabus. Instructors in online courses are responsible for providing students with clear instructions for how they are required to participate in the course. Additionally, instructors are responsible for incorporating specific instructional activities within their course and will, at a minimum, have weekly mechanisms for documenting student participation. These mechanisms may include, but are not limited to, participating in a weekly discussion board, submitting/completing assignments in Blackboard, or communicating with the instructor. Students aware of necessary absences must inform the professor with as much advance notice as possible in order to make appropriate arrangements. Any student absent 25 percent or more of the online course, i.e. non-participatory during 3 or more weeks of an 11 week term, may receive an F for that course. Instructors may also file a Report of Unsatisfactory Progress for students with excessive non-participation. Any student who has not actively participated in an online class prior to the census date for any given term is considered a "no-show" and will be administratively withdrawn from the class without record. To be counted as actively participating, it is not sufficient to log in and view the course. The student must be

submitting work as described in the course syllabus. Additional attendance and participation policies for each course, as defined by the instructor in the course syllabus, are considered a part of the university's attendance policy.

#### **COURSE REQUIREMENTS and GRADING CRITERIA:**

1. Final Examination- The exam will cover materials from the Weekly Lectures and articles in the NIV Study Bible, and specifically referenced materials from the textbook.
2. Weekly Quizzes- Quizzes will come entirely from the textbook. One weekly quiz. Not timed and you may retake it if you do poorly. Open book.
3. Discussion Board: Threads will come from the Biblical Readings
  - a. Students must participate in Discussion Board questions facilitated by the instructor-
  - b. Students must post a 100 word response to the initial thread.
  - c. These questions are reflective in nature, without a "correct" answer. They are intended to encourage thought about the readings and lectures as well as to facilitate dialogue on these topics
  - d. Proper grammar is expected when posting to the Discussion Board. If you need assistance with proper English grammar Wayland provides assistance in the writing lab. Please follow Wayland's guide to online behavior as well. Be respectful of your classmates and their opinions
  - e. Sunday deadline for initial responses to instructor's threads (questions). Students should also engage in robust discussions with their classmates about posts on discussion boards. There is a minimal expectation of two substantive responses to classmates' posts per week. These interactions are due by Sunday of the week following the initial posts. All discussion posts should strive to build community and enhance the learning process.
  - f. The Discussion Boards will remain open until the day before the final exam. This will allow you to make additional responses to threads as we gain a greater understanding to topics. Your initial post is still due the week of the assignment and you'll only receive half credit if you post late.

4. Journal Entry
  - a. Students are expected to compose two journal posts over the course of the term. Journal posts should be at least 400 words in length. Students will journal on specific weeks in response to specific content covered in the course.
5. Research Paper: Each student will complete a 8-10 page research paper on one of the topics listed on blackboard under the Content Folder "Research Suggestions." Paper must follow the Kate L. Turabian. *A Manual for Writers of Research Papers, Theses, and Dissertations*, 9<sup>th</sup> Edition. Chicago: University of Chicago Press, 2018. ISBN 978-0-226-43057-7.
