- 16. Course Requirements and Grading Criteria: Grading is based on quizzes, discussion board posts, a midterm, a final exam, and participation. Quizzes will be delivered via blackboard and will be based on textbook readings. Quizzes will be composed of multiple choice and fill-in-the-blank question options. Every week a discussion board question will be posted, and students are to respond in one paragraph length to the question and comment on two classmates' posts. Midterm and final exams will also be delivered in blackboard, composed of multiple choice and fill-in-the-blank question options. Participation is based on a student's overall attendance in the course, especially timely discussion board participation.
