13. Course Outcome Competencies:

At the completion of the course, the student will:

- 1. Understand the nature of the American legal system.
- 2. Be cognizant of the potential liability for injuries in the supervision, management, and conduct of sport, and of strategies for limiting liability.
- 3. Understand the rights and responsibilities of management, employees, participants, and clientele with respect to negligence law, and the potential for management liability.
- 4. Know the basic components of preventive law planning and to be able to apply them in sport settings.
- 5. Understand legal issues relevant to sport in the areas of contract, intentional tort, intellectual property, and criminal law.
- 6. Be able to apply selected legal principles to cases involving civil rights and civil liberties of personnel, participants, and clientele. Particular application is made to civil rights of women, minorities, and persons with disabilities.
- 7. Increase awareness of current legal issues in sport.
- 8. Learn to think critically and analytically about the mutual interaction between the law and society.

14. Attendance Requirements:

As stated in the Wayland Catalog, students enrolled at one of the University's external campuses should make every effort to attend all class meetings. All absences must be explained to the instructor, who will then determine whether the omitted work may be made up.  - c. This is not graded, but is mandatory to be considered a participant in class.

- B. Discussion Board Questions will assess attendance and competencies 1, 2, 3, 4, 5, 6, 7, & 8
 - a. Develop a thorough response to each prompt or question
 - i. Will require consideration of each of the assigned readings
 - ii. Although it will not be graded formally, you are expected to read other student responses after you submit your own. I would encourage you to post a thoughtful and constructive reply to your classmates to encourage an exchange of ideas. This will enhance your learning and that of your classmates.
 - b. Text should follow APA formatting standards, including any references cited
 - c. Post to Blackboard under "Discussion Boards" tab
 - d. 5 worth 10 points each
 - e. Due by 9:00 PM (CST Plainview time) Monday night following assigned readings
- C. Case Briefs will assess competencies 1, 2, 4, 5, 6, 7, & 8
 - a. Write a case brief for a recent legal decision that is:
 - i. Not fully outlined in the text (may be mentioned or cited)
 - ii. Related to the course and your field of expertise
 - iii. Of interest to you
 - b. Format should follow the description presented in the Sharp text, on pp. 41-43, and further described here: link
 - i. Note that there should be 5 sections in each case brief:
 - 1. Citation information (should resemble Blue Book legal format)
 - 2. The key <u>facts</u> of the case
 - 3. The issues presented to the court
 - 4. The holding (ruling) of the court
 - 5. The <u>rationale</u> for the court's decisions
 - c. Uploaded to Blackboard under "Assignment Uploads" tab
 - d. 5 worth 10 points each
 - e. Due by 9:00 PM (CST Plainview time) Monday night following assigned readings
- D. Research Paper will assess competencies 1, 2, 3, 4, 5, 6, 7, & 8
 - a. Write 10-12 page paper analyzing the legal standing of a current issue. Although the actual questions will vary by topic, consider at a minimum these issues: What are the facts of the issue? Who are the stakeholders in the legal decision? Who holds jurisdiction? What legal standards (laws and statutes) and cases should be applied? Is there legal precedence? Are there contrary legal points of view that must be considered? What will the expected and potential unintended consequences of either side winning the case? Is a compromise or collaboration possible or preferable to both sides? How can we prevent (or reduce the rate of occurrence of) this issue from occurring in the future?

- i. Use the Marquette Sports Law Review and LexisNexis to start your research. However, don't simply restate the findings of the authors. This should be your analysis. Remember to cite any sources you obtain information from.
- ii. Topic should be pre-approved by instructor an email is sufficient.
- b. As a rule of thumb, paper should include approximately 1 primary reference resource per page of text.
- c. All papers should be formatted using the latest edition of APA.
 - i. Any submission that appears to be a rough draft as defined as "several (more than 2-3 unique) grammatical or APA errors per page, including the references" will be returned with a grade of 1 point.
 - 1. If you have any questions, concerns, or problems with APA formatting, please feel free to contact me or seek help through the WBU Writing Center.
 - ii. Legal citation is complex and typically requires resources not available to students outside of a law firm. The APA Publication Manual has several suggestions and examples.

- E. Organizational Review will assess competencies 1, 2, 3, 4, 5, 6, 7, & 8
 - a. Prepare a PowerPoint (or similar) presentation on a sports or physical activity organization that you are intimately familiar with. If you do not have an organization, become familiar with it including website review and interviewing with administrative staff. Presentation should include any formal policies and procedures that are written and published for the open public. Private or secret information should not be divulged. Presentation should include an outline of the corporate policies and procedures intended to mitigate liability and prevent negligence and other torts. Additionally, presentation should include any required personnel standards that are designed to mitigate risk (i.e., require all coaches to have current CPR and AED certification). Note that the purpose of this assignment is to become familiar with the breadth and depth of the interactions between legal requirements and daily practice and procedures of an organization NOT to just look for places where an organization is failing.
 - i. Use APA format for all text and citations.
 - 1. The same "rough draft" standard from the research paper instructions is expected here.
 - ii. Length will be determined by content.

- G. Grade of Incomplete The university catalog, link, states that "an incomplete may be given within the last two weeks of a long term . . . to a student who is passing, but has not completed a term paper, examination, or other required work for reasons beyond the student's control." For this course, I will approve any request that includes a statement of

need due to "reasons beyond the student's control" and that is requested in the last two weeks of the term. However, I can only approve the request if you are both requesting an extension for *one assignment* and are otherwise *passing* (defined as at least 60% of the points expected based on the position within the course, excluding the assignment within the request). More extensive requests may be possible through working with WBU academic administration.
