- I hereby enroll in the Fixed Tuition Plan (the Plan) at Wayland Baptist University for the Plainview campus. By signing this contract, I agree to abide by the terms and conditions of the Plan as outlined in this contract. I understand that undergraduate tuition will be fixed at a rate of \$635.00 per credit hour for each of the next **eight consecutive** terms, beginning with the Fall 2016 term.
- I understand I must enroll in a minimum of 12 credit hours of face-to-face classes on the Plainview campus in each of the eight consecutive terms, which are defined as the long Fall and Spring terms offered at the Plainview campus. Summer terms do not count as one of the eight consecutive terms due to the difficulty of completing 12 credit hours in a short Summer term. However, if desired, classes may be taken in the Summer term at the fixed rate of \$635.00 per credit hour.
- I understand I must maintain a 2.0 GPA or greater.
- I understand I may opt into the Plan during an open registration period and prior to the first day of class of the initial term for which I am enrolling at WBU via any of the three methods indicated below.
- The deadline for submission for Fall 2016 is **Wednesday, August 24th**. This form must be completed and sent to the Business Office at WBU.

TERMS AND CONDITIONS OF THIS CONTRACT

Please read both sides of this form.

- This Plan is open only to new first-time, full-time undergraduate freshmen entering in the 2016-2017 academic year at the Plainview campus. Transfer or re-admitted students entering in the 2016-2017 academic year are not eligible for this Plan.
- Full -time is defined as being enrolled in a minimum of 12 credit hours of face-to-face courses on the Plainview campus.
- Upon *initial* registration, students electing the Fixed Tuition Plan may lock also in the dorm rate at Jimmy Dean, Owen and Davis halls as available on a first-come, first-served basis. No other dorms may be included in the Fixed Tuition Plan.
- Students may opt into the Plan during an open registration period and prior to the first day of class of the initial term at WBU.
- The deadline for submission Fall 2016 is **Wednesday, August 24th**. This form must be completed and sent to the Business Office at WBU as indicated on page 1.
- Students may opt out of the Plan but not back in. Students may opt out only during an open registration period and prior to the first day of class of the next regular academic term.
- University fees, meal plans and textbooks are not included in the Plan and are subject to change.
- Students must be enrolled in a minimum of 12 credit hours of face-to-face courses on the Plainview campus in each of the eight consecutive terms beginning with the Fall 2016 term.
- Enrollment must be continuous full-time enrollment for eight consecutive terms to receive all program benefits. Terms are defined as the long Fall and Spring terms offered at the Plainview campus. Summer terms do not count as one of the eight consecutive terms due to the difficulty of completing 12 credit hours in a short Summer term. However, if desired, classes may be taken in the Summer term at the fixed rate of \$635.00 per credit hour.
- Students must maintain a 2.0 GPA or greater.
- PEP program participants and full scholarship athletes may not enroll in the Fixed Tuition Plan.
- Students who drop from full-time status to part-time status will no longer be charged at the fixed rate and will be charged the regular tuition rate from that time forward, and may not return to the Fixed Tuition Plan.
- Students whose enrollment is canceled for any reason (including withdrawal, suspension or expulsion) shall be refunded, in applicable cases, in accordance with the general refund policy of the University. The Fixed Tuition Plan contract is then voided and may not be reinstated.
- Students not graduating in spring 2020 will pay the prevailing tuition rate for any additional terms.
- The Plan cannot be assigned or transferred to any other person.
- Students electing the Plan may request one free three-hour course (face-to-face or online) upon completion of 30 Wayland non-concurrent hours. The request for the free course must be initiated by the student and redeemed in the next regular academic term while enrolled in a minimum of 12 credit hours. The student must have a 2.0 GPA or greater to request the free course.
