quizzes, discussion boards, examinations, and course paper along with gaining the course competencies to be successful in your area of sport management.

- 2) Discussion Participation
 - a. A discussion board will be available on Blackboard every week
 - b. Each student will consider the proposed topic, and write an original concise response (no more than 100 words)
 - Must use and site (APA format) two outside sources to support your post
 - c. After generating a response, each student is expected to review peer responses and comment on two student's post
 - i. Must include at least one legal citation
 - d. 8, worth 20 points each
- 3) Chapter Quizzes assesses outcome 1, 2, 3, 4, & 5
 - a. Each week you will have a quiz that will assess your competencies for each chapter
 - b. 8, worth 20 points each
- 4) Examinations assesses outcome 1, 2, 3, 4, & 5

- 5) Case Study Paper
 - a. You will be given several case studies to choose from the Case Studies in Sport Law E-Book. I will give the Case Study Number and Title that I would like you all to choose from in a Word Document that can be located in the Case Study Papers tab in Blackboard.
 - b.  - c. You will have 1 Case Study paper to complete for the semester, worth 200 points
 - i. A case study paper
 - 1. For your paper you will choose one of the case studies, **found in the word document in Blackboard**.
 - 2. Your task will be to analyze, argue and discuss the case in comparison with the ruling of the court.
 - 3. Use the Case Study Review Questions at the end of each Case Study to guide your thoughts and the content of your paper
 - a. Please do not just answer the review questions for they are only there to lead you to a better understanding of the important elements of the case and help you effectively analyze, argue and discuss the case in comparison with the ruling of the court

- b. Identify at least *3 outside sources* to support your arguments or discussion with the case study you have chosen (Note: Refer to the LexisNexis located above in the optional materials portion of your syllabus indicated as 12.)
- c. Be sure to cite those sources within your text and in a reference list (*APA format*)
- d. In the conclusion of your case study paper, discuss what things you have learned from this case study to help you avoid litigation as a sports manager in the future.
- 4. Your paper should be in Essay Format and a minimum of 1,000 words (an example paper is located in the Case Study Papers tab in blackboard)
 - be clear, well organized, and concise.
 - be free from grammatical and spelling errors.
 - be typed (12 point) and double spaced with 1 inch margins on left and right, with name, date, course in upper right.
 - APA guidelines should be followed in all cases.
