This is to confirm you are scheduled to teach a course for Wayland Baptist University, WBUonline, as follows:

Rate of Pay\*: \$1900

The rate of pay for this course is based on the academic level of the course and on whether or not you have a terminal degree. If enrollment for the course is less than 4, the instructor will be paid a percentage based on the number of students in the course. Tuition for an undergraduate course is 451 per hour, and tuition for a graduate course is 538 per hour.

Payments will begin once the Office of the Vice President of Academic and Graduate Services has received all of the following documentation: <u>WBU Application, all official transcripts, resume/vitae, W-4, I-9 and copies of documents for the I-9, and the direct deposit form</u>. After these requirements are met, partial payments will be made semi-monthly, with the first payment being issued on the second regular Wayland semi-monthly pay date occurring after the session begins. Required and requested deductions will be withheld from each payment. The final payment will be made on the pay date immediately subsequent to the end of the session (either the 15th day of the month or the last day of the month, whichever applies). If the course is cancelled for any reason, no payment will be made.

In accepting this appointment, you hereby agree to provide **15 contract hours of instruction per credit hour** for this assignment. You further agree to provide **appropriate interaction** between yourself and your students and among students, and to meet design criteria stipulated in the **Effective Design Initiative** (EDI), which may be found in WBUonline Toolbox.
